

## TERMS AND CONDITIONS FOR COVERLAND UK LTD'S GIVEAWAY PRIZE DRAW (THE "Prize Draw")

These terms and conditions govern your entry into Coverland UK Ltd's Giveaway Prize Draw (the "Prize Draw"). By entering, you confirm your acceptance of these Terms.

***Please read these Terms and the associated Privacy Notice carefully before you enter the Prize Draw as they will govern your entry to the Prize Draw. By entering the Prize Draw, you confirm your acceptance of these Terms.***

### INFORMATION ABOUT US

1. The Prize Draw is promoted by Coverland UK Ltd, trading as Beyond Venues, a company registered in England and Wales (company number 03909172). Registered office: Ashford Hall Estate Office, Ashford Hall, Bakewell, DE45 1QA.

For the purpose of these Terms and Conditions, Coverland UK Ltd shall hereafter be referred to as "Beyond Venues."

### HOW TO ENTER THE PRIZE DRAW

2. To enter, during the Prize Draw Period, customers must:
  - a) Submit an official guest entry form after their stay, OR;
  - b) Complete an online form via link from website or social media channels.
3. The Prize Draw opens for entries on 12 May 2026 and closes at 23:59 on 30 October 2026. Entries received after this time will not be valid.
4. Only one entry per person is permitted unless otherwise stated.
5. Entrants must be aged over 18 years old

### THE PRIZE

7. A winner will be randomly selected by 5pm on 4 November 2026, this decision will be final.
8. The prize consists of a complimentary 3-night stay for up to 8 guests at one of the promoter's Peak District properties.

  - Is accommodation only
  - Does not include travel, food, or additional services
  - Is subject to availability
  - Must be booked and taken within 12 months of the winner being notified

  - A Damage Deposit will be held via pre-authorisation on your chosen card. You will be informed of the amount at the time of your booking dependent on

your chosen property. The venue will be assessed after your Holiday. If no loss or damage is discovered, we will release all funds back to you within 7 days. Otherwise, if any loss or damage is discovered then you will be informed of the amount to be charged.

10. The prize is non-transferable, non-refundable, and cannot be exchanged for cash or any other alternative.

### **RESTRICTIONS ON ENTRY**

11. The Prize Draw is only open to entrants aged 18 years or over.
12. Employees of the promoter and their immediate families, or anyone otherwise connected with the organisation, are not eligible to enter.
13. Use of false or multiple email addresses to enter is prohibited and will cause disqualification.
14. Beyond Venues reserves the right to disqualify any entry that it believes breaches these Terms or is otherwise inappropriate.

15. 1 (one) winner will be randomly selected by 4 November 2026. The winner will be contacted within 7 days of the draw by Beyond Venues via the email address used to enter the Prize Draw.
16. The winner must respond within 14 days of notification to claim their Prize. Failure to respond or provide required information will result in forfeiture of the Prize, and the promoter reserves the right to select an alternative winner.
17. Beyond Venues will make all reasonable efforts to contact the winner. If a winner cannot be contacted or has not claimed their prize within 14 (fourteen) days, Beyond Venues reserves the right to offer the Prize to the next eligible entrant selected from the valid entries received during the Prize Draw Period.
